## Integrating new national CESSDA-members (1)

1. Identification of relevant resources and organisations
2. Analysis of capacities, human resources and organisational/institutional settings of the identified resources
3. Analysis of the national data sharing culture and prevailing research traditions in the respective countries
4. Evaluation and discussion of models of organisational settings in the potential new members archives

## Integrating new national CESSDA-members (2)

5. Setting up recommendations for the administrative bodies regarding the potential financial contributions from within and outside the CESSDA network for incorporating new members to the CESSDA RI
6. Developing training and staff exchange programmes for new CESSDA-personnel
7. Planning working groups and training teams from the existing CESSDA RI/new staff

## Task 2: Integrating agencies and organizations hosting important data collections outside CESSDA

1. Identify organisations that would remain outside the CESSDA RI but whose resources would be beneficial to the overall aims and objectives of the infrastructure.
2. Explore and evaluate possible forms of cooperation with organisations/resources outside the CESSDA RI.
3. Devise programmes for interoperating with these organizations
